## **Refund policy for boarding fee at Campus Gränna, JUE**

Jönköping University Enterprise, located at Campus Gränna, runs Pathway Programmes. The programme fee includes a boarding fee. This boarding fee is mandatory for all students at the Pathway Programmes, including students who are not required to pay tuition fee. Refund of the boarding fee is possible after application and only in the cases and to the extent stated in this document.

The Managing Director's decision is to implement the following refund policy as of 2022-11-09 until further notice.

### **Refund of boarding fee due to cancellation by admitted student**

#### **Pathway Semester**

Student admitted to Pathway Semester who cancels their admission **before** 31 July (if the studies start in autumn) or 31 December (if the studies start in spring) and applies for a refund of the boarding fee will receive a full refund of the paid boarding fee.

Student admitted to Pathway Semester who cancels their admission **after** 31 July (if the studies start in autumn) or 31 December (if the studies start in spring) but **before** 30 September (if the studies start in autumn) or 28 February (if the studies start in spring) and applies for a refund of the boarding fee will receive a refund of 73% (corresponding to accommodation, food, course literature, Student Union fee and bus pass for one semester).

#### **Pathway Year**

Student admitted to Pathway Year who cancels their admission **before** 31 July (if the studies start in autumn) or 31 December (if the studies start in spring) and applies for a refund of the boarding fee will receive a full refund of the paid boarding fee.

Student admitted to Pathway Year who cancels their admission **after** 31 July (if the studies start in autumn) or 31 December (if the studies start in spring) but **before** 30 September (if the studies start in autumn) or 28 February (if the studies start in spring) and applies for a refund of the boarding fee will receive a refund of 73% for the first semester and 100% for the second semester (corresponding to accommodation, food, course literature, Student Union fee and bus pass).

Student admitted to Pathway Year who cancels their admission **after** 30 September (if the studies start in autumn) or 28 February (if the studies start in spring) but **before** 1 December (if the studies start in autumn) or 1 August (if the studies start in spring) and applies for a refund of the boarding fee will receive a refund of 0% for the first semester and 100% for the second semester.

### **Pathway Summer**

Student admitted to Pathway Summer who cancels their admission **before** 30 June and applies for a refund of the boarding fee will receive a full refund of the paid boarding fee.

Student admitted to Pathway Summer who cancels their admission **after** 30 June, but **before** the start of the studies, and applies for a refund of the boarding fee will receive a refund of 37% (corresponding to accommodation, food, course literature, and Student Union fee).

Student admitted to Pathway Summer who cancels their admission after the official start of the studies and applies for a refund of the boarding fee will receive a refund of 0% (no refund of the boarding fee).

### **Refund of boarding fee if student for special reasons is prevented from participating in the studies**

An individual assessment will be done if the student is prevented from participating in the studies for special reasons. The student should submit documents supporting the special reasons.

Student who is prevented from starting their studies due to special reasons could receive a full or partial refund of the boarding fee. Decision-maker at JUE will make an individual assessment if the reasons the student gives can be considered special reasons. Rejection from the Swedish Migration Agency is considered to be a special reason.

### **Refund of boarding fee if student does not arrive and has not notified the university of cancellation**

#### **All Pathway programmes**

Student admitted to a Pathway programme who has not contacted Pathway Admissions before the start of the studies, not taken part of the mandatory roll call, nor notified Pathway Admissions of their cancellation is not eligible for any refund of the boarding fee.

### **Refund of boarding fee due to study interruption (dropping out from studies)**

#### **Pathway Summer**

Student who has started Pathway Summer and then drop out from their studies is not eligible for any refund of the boarding fee.

#### **Pathway Semester**

Student who has started Pathway Semester (registered) and then drop out from their studies **before** 30 September (if the studies start in autumn) or 28 February (if the studies start in spring) and applies for refund of the boarding fee will receive 73% refund (corresponding to accommodation, food, and bus pass for one semester) and a deduction for the Student Union fee.

Student who has started Pathway Semester (registered) and then drop out from their studies **after** 30 September (if the studies start in autumn) or 28 February (if the studies start in spring) and applies for refund of the boarding fee will receive 0% refund (no refund of the boarding fee).

## Pathway Year

Student who has started Pathway Year (registered) and then drop out from their studies **before** 30 September (if the studies start in autumn) or 28 February (if the studies start in spring) and applies for refund of the boarding fee will receive 73% refund of the boarding fee for the first semester (with deduction for the Student Union fee) and 100% for the second semester.

Student who has started Pathway Year (registered) and then drop out from their studies **after** 30 September (if the studies start in autumn) or 28 February (if the studies start in spring) but **before** 1 December (if the studies start in autumn) or 1 August (if the studies start in spring) and applies for a refund of the boarding fee will receive 0% refund for the first semester and 100% refund for the second semester.

Student who drops out from their studies **after** 1 December (if the studies start in autumn) or 1 August (if the studies start in spring) but **before** the start date of the second semester will receive a refund of 75% of the boarding fee for the second semester.

Student who drops out from their studies after the start date of the second semester is not eligible for any refund of the boarding fee.
